Please take notice that pursuant to paragraph 15 of the Court’s April 14, 2021 Final Order Approving Class Action Settlement and paragraph 13 of the Final Judgment, the Court held a further hearing on February 1, 2022 at 8:30 a.m., regarding its order to show cause with regards to Plaintiffs’ Counsel’s compliance with the terms of the Settlement. At the initial compliance hearing on December 2, 2021, Plaintiffs’ Counsel presented the Court with 24 claims in which the Claimants disputed the rejection of their claims. At that hearing, the Court set a January 11, 2022 deadline for these Claimants to submit documentation in support of their disputes and continued the compliance hearing to February 1, 2022. Although these 24 Claimants were notified of the January 11 deadline, none of them submitted documentation in support of their dispute. Accordingly, there were no disputes for the Court to resolve at the February 1, 2022 compliance hearing. Those 24 claims are now rejected pursuant to the Claims Administrator’s determination. In addition, the Court found that Plaintiffs’ Counsel fully complied with the Final Order Approving Class Action Settlement, the Final Judgment and the Settlement and instructed that the matter be closed and the Net Settlement Fund be distributed.
