WHEREAS, by Order dated April 27, 2020 ("Preliminary Approval Order" or "PAO"), the Court preliminarily approved the Settlement and approved the forms and method of notifying the Class of the Settlement;

WHEREAS, pursuant to the Preliminary Approval Order, notice of the Settlement includes joint notices advising the Class of both this Settlement and the settlement of the related State Court litigation, Hsieh, et al. v. Snap Inc., et al., Superior Court of California, County of Los Angeles, No. BC669394, *Iuso v. Snap Inc.*, et al., Superior Court of California, County of San Mateo, No. 17CIV03710 ("State Settlement");

WHEREAS, under the terms of the Settlement and pursuant to the Preliminary Approval Order, both this Court and the State Court are required to preliminarily approve their respective settlements and the joint notices prior to notice being issued to the Class;

WHEREAS, the State Court plaintiffs filed their motion for preliminary approval of the State Settlement on April 27, 2020;

WHEREAS, following two hearings and additional submissions in connection with the State Settlement, the State Court intends to enter an order granting preliminary approval of the State Settlement on November 10, 2020;

WHEREAS, the Court has reviewed and considered the Parties' Joint Status Report and request for modification of certain settlement-related deadlines and the final settlement hearing date currently scheduled for November 30, 2020 and is otherwise fully advised of the premises.

Accordingly, it is hereby **ORDERED AND ADJUDGED** as follows:

- 1. The Parties' request is **GRANTED**.
- 2. The final settlement hearing scheduled for November 30, 2020 to determine whether, among other things, the proposed Settlement is fair, reasonable, and adequate to the Class and should be finally approved by the Court, is reset for February 22, 2021 at 1:30 p.m. The Court will hold the Settlement Hearing in Courtroom 10A-10th Floor of the First Street Courthouse, 350 W. 1st Street, Los Angeles, CA 90012.
- 3. The Court may adjourn the Settlement Hearing or decide to hold the Settlement Hearing telephonically without further notice to the Class.
- 4. The deadline for mailing, or emailing, the Postcard Notice to potential Class Members and mailing the Notice and Claim Form to brokers and nominees is **November 25, 2020** (i.e., the "Notice Date"). PAO ¶ 4(a).
- 5. The deadline for: (i) requesting exclusion from the Class (PAO ¶ 13); (ii) submitting an objection to any aspect of the Settlement and entering a notice of appearance (PAO ¶¶ 16-17); and (iii) submitting a Claim Form in order to be potentially eligible to receive a distribution from the Settlement (PAO \P 8) is **January 25, 2021**.
- 6. All other dates established pursuant to the schedule set forth in the Preliminary Approval Order are not altered by this Order.

7. The Court retains jurisdiction to consider all further applications arising out of or connected with the Settlement. IT IS SO ORDERED. DATED this 4 day of November, 2020. HON. STEPHEN V. WILSON UNITED STATES DISTRICT JUDGE
